Request for Information - Ref FOI/001

We acknowledge your request for the following information:

I am writing to request the following information relating to communications between the Scottish Biometrics Commissioner and Hikvision

- A copy of all emails/correspondence between the Commissioner and Hikvision, or its representatives [such as marketing or PR firms] since 1st October 2022
- A copy of any agenda, minutes, or attendee list for any meeting between the Commissioner and Hikvision in the last 6 months

Your request was received on 21 February 2023 and has been handled in accordance with the Freedom of Information (Scotland) Act 2022 (FOI(S)A)

Responding to each part of your request in turn the position is as follows:

A copy of all emails/correspondence between the Commissioner and Hikvision, or its representatives [such as marketing or PR firms] since 1st October 2022

Please find attached the correspondence that we hold which is within the scope of your request which consists of emails between the Commissioner and Hikvision.

We have withheld information which consists of third party personal data as we consider this information to be exempt from disclosure under section 38(1)(b) of FOI(S)A – third part personal data. The reasons for the use of this exemption are set out in the attached refusal notice.

A copy of any agenda, minutes, or attendee list for any meeting between the Commissioner and Hikvision in the last 6 months

A meeting between the Scottish Biometrics Commissioner and Hikvision took place on 24 February 2023. This is the only meeting the Commissioner has had with Hikvision. The information we hold in relation to the meeting consisting of the invitation letter to the Commissioner; the Commissioner's response; and notes of the meeting are publicly available on the website for the Scottish Information Commissioner and can be accessed at the following link:
