Request for Information – FOI-008

We acknowledge your request for the following information:

Provide the following information for the years 2022, 2023 and 2024 in relation to the commissioner and your staff:

- How many work at home all the time, and paid band
- The number of days, weeks or months worked at the office
- The number of days, weeks or months worked from outside the United Kingdom
- The country which they worked from

Please broke this down by job title and dates for the commissioner and staff.

Your request was received on 9 May 2025 and has been handled in accordance with the Freedom of Information (Scotland) Act 2022 (FOI(S)A)

Responding to each part of your request in turn the position is as follows:

## How many work at home all the time, and paid band

Across the team we have a hybrid approach to work. This allows the team to work from home or in our Edinburgh office depending on their requirements. This flexible approach ensures individual needs are met and supports a good work/life balance.

The pay bands of staff are 2 x Band 5 and 1 x Band 3.

## The number of days, weeks or months worked at the office

The team often attend meetings in the office but are guided by partners and those attending the meeting as to whether they prefer a face to face or online meeting.

The office is also available should any of the team wish to work there, however we do not keep details of when the team attend the office.

# The number of days, weeks or months worked from outside the United Kingdom

The entire team visited colleagues in Brussels over 23 and 26 May 2023. Details of this visit are available on our website.

Our Operations Manager also worked from Brussels while attended the Law, Ethics & Policy of Artificial Intelligence course at KU Leuven University between 1 and 10 July 2024.

#### The country which they worked from

As above the team worked in Belgium between 23 and 26 May 2023 and the Operations Manager also worked from Belgium between 1 and 10 July 2024.
