### Dear Requester,

Request for Information - Ref FOI/003

We acknowledge your request for the following information:

I am writing to request the following information relating to the SBC:

- A list of all meetings the Commissioner has taken with private companies since taking office.
- Details of all hospitality received by the Commissioner since taking office, including the cost who paid for it and any itemisations
- A copy of the SBC's governance handbook

Your request was received on 20 April 2023 and has been handled in accordance with the Freedom of Information (Scotland) Act 2022 (FOI(S)A)

Responding to each part of your request in turn the position is as follows:

# A list of all meetings the Commissioner has taken with private companies since taking office.

We sent you an email on the 24 April 2023 asking for clarification of this point. We want to establish what you mean by private companies as the Commissioner has had many routine meetings with private companies not involved in the policing or biometrics sector such as our website provider, HR consultants, social research companies, internal auditors and insurance providers.

Per our FOI response dated 9 March 2023 on the Commissioner's meeting with Hikvision this is the only meeting the Commissioner has had with them. The only other meeting that the Commissioner has had with a policing technology company since taking office was with Motorola on 11 January 2023. That meeting comprised of a demonstration by Motorola of the biometric functionality within their Pronto PDA solution which is used by many UK police forces, including Police Scotland.

Our newsletters also detail any meetings attended by the Commissioner and our Operations Manger. This information can be found on our website. <a href="Quarterly">Quarterly</a> <a href="Newsletter No 7 December 2022 | Scottish Biometrics Commissioner">Scottish Biometrics Commissioner</a>. Our newsletters are now published half yearly and the next one will be available in June.

Our current policy is not to accept gifts or hospitality and confirm that neither the Commissioner or any member of SBC staff has accepted any gifts or hospitality since our function was established therefore we do not hold this information.
